### **Landscape Committee**

Tony Jackson is getting involved with Prestige Pro to handle the affairs/invoices. Myrtle will shadow him until he learns the position.

\$150 was spent to remove a tree limb that fell in the common area.

Tony got 3 quotes for trimming Cabbage Palms in the Park. They are going with Apopka Tree Service. Money has been budgeted for this.

On March 1<sup>st</sup> one bulb was replaced in the entrance lights and two more bulbs were replaced April 1<sup>st</sup>. Karin will reorder 12 more bulbs.

#### **Water Committee**

Joe reported that valve replacement with RCM utilities is \$242 vs. \$251 with Utility Tech.

Joe called Mike Franklin to draw up plans for a new shed at the water plant. Plans will run between \$600 - \$1000. This will be discussed further at the next meeting.
