Keeping your home and property maintained according to our Architectural Guidelines and CC&R's contributes to keeping our community beautiful and a nice place for all of us to live!

Below are a few of the guidelines that need regular attention:

- Lawns and landscaping: regular maintenance of mowing and weeding.
- Trash cans should be stored out of sight on non-scheduled p/u dates.
- RV's, Boats and trailers, not to be parked in driveways over 48 hrs.
- Mailboxes need to be repaired and painted when needed to keep nice appearance.
- Cars should not be parked on lawns or in common areas.
- Major Changes in landscaping such as large tree removal or planting of trees that will become large, needs prior A.R.C. approval.
