### ARC Reminder

Please don't forget to get a Request Form from the website or Architectural Review Committee and submit it to get an approval for painting your home when changing colors. Or any other project that requires approval stated in the CC&R's. This helps us keep our neighborhood in harmony with selected colors that appeal to all. We appreciate your help as a resident by doing this to continue having a beautiful community to live.

NOTE: Starting December,2014 the ARC Meetings will be held on the first Tuesday of each month at 7:00 PM. only If there are any request to be reviewed. If you have any projects coming up that require approval (check CC&R's) then please make sure we have your request form by the last week of the previous month for scheduled meeting. Meetings are always posted on the message board at our front entrance!

### Trash Collections

Trash Collections: By now everyone has their new carts for trash and recycle. We have had several inquiries still about the new schedule and most importantly how to place them at the curb. Because carts are hoisted by a mechanized arm, the county has asked that they be placed at the curb with the wheels facing the resident's home. Carts for trash and recycling, which are picked up the same day, should be placed at the curb at least 4 feet apart and away from impediments such as trees, cars and mailboxes. There is a label on the recycle cart that tells what you can recycle. Also, you have six months to change the size of container you have if you feel it is too big or too small for your needs without additional charge. If you have any other questions you may call Lake County Solid Waste Department at 352-343-9400.

Please remember to keep your carts out of sight in garage or if stored outside then they shall be kept behind fence or in area not visible from any street or adjacent lot, like shrubs etc.
